

2009 Borden Milk/NCHA World Championship Futurity \$200,000 LIMITED NON-PRO CONTEST

(Will be a Separate Contest)



- The Non-Professional class limitation is based on Non-Professional earnings up to Dec. 1, 1995 plus all money won in all approved classes after that date whose lifetime earnings in NCHA-approved and/or sponsored events equal less than \$200,000 and is restricted to current NCHA Non-Professional card holders.
- Nomination fees for Limited Non-Pro Contest:
On or before **September 1, 2009** \$500
On or before **October 1, 2009** \$925*
Total \$1,425
There will be a 10-day grace period. (Official postmark by US Postal Service)
Late entries or payments postmarked after the ten (10) day grace period will be subject to a penalty of 50% of the payment. *There is a \$25 per entry cattle surcharge added to the final payment
- The \$200,000 Limited Non-Pro contest will consist of one go-round and a 75 horse semi-finals with the high scoring twenty percent (20%) with a maximum of thirty (30), will advance to the finals (max 5 sets)

- regardless of the number of horses for the semi-finals and (max 2 sets) for the finals. There will be no premium payments made to any entrants who do not qualify in the limited classes.
- In the event there are less than twenty-five (25) entries in a class, as of October 1, 2009, there will not be a working finals. Payout will be made according to the NCHA mandatory payout.
 - All finalists will receive premium checks.
- Riders may ride two (2) horses of any sex in the Limited Non-Pro Contest.
 - If a rider has attempted to compete in these classes and is found to be ineligible, disciplinary action may be taken. The burden of proof of eligibility is upon the rider.
 - All rules of the 2009 NCHA World Championship Futurity will apply in this event where applicable.
