

# 2011 XTO Energy/NCHA Super Stakes & Super Stakes Classic



# Amateur Cutting Horse Class

1. The 2011 Super Stakes & Super Stakes Classic Amateur Cutting Horse Contests will be limited to NCHA Non-Professional card holders whose lifetime earnings in NCHA Approved Non-Professional and/or Amateur Contests equal less than \$100,000.00 and whose Limited Age Event earnings are less than \$50,000.00.
  - a. No person may compete in this class who has ridden, trained or assisted in training horses or horse riders, on horseback, for remuneration directly or indirectly, nor may such a person's spouse, ex-spouse, relative of either living in the same household, or children. Any person who receives pay to work in any manner on the premises of a horse training operation shall be ineligible, as well as any person who has been granted apprentice trainer status. In addition, any person who has or is currently involved in a spousal relationship with a horse trainer is ineligible for Amateur status.
2. The 2011 Super Stakes Amateur Cutting Horse Contest will consist of one go-round plus finals for the high scoring twenty-five (25%), with a minimum of ten and a maximum of thirty (30). The 2011 Super Stakes Classic will consist of one go-round plus finals for the high scoring twenty-five (25%) percent with a minimum of ten and a maximum of thirty (30).
  - a. In the event there are less than twenty-five (25) entries in a class, there will be no finals and premiums will be paid based on the high scoring twenty-five percent (25%) in the go-round.
3. Riders may ride only two horses in the Super Stakes Amateur and four horses of any age combination in the Super Stakes Classic Amateur class.

4. **Nomination Fees Super Stakes & Super Stakes Classic**  
 On or before Feb 15, 2011 . . . . . \$1005  
 (\$500.00 jackpot/\$450.00 cattle charge/\$25 cattle surcharge/\$10 drug fee)  
 Late entries or payments received after the 10-day grace period (official post-mark by US Postal Service) will be subject to a penalty of fifty percent (50%) of the payment. \*There is a \$25 cattle surcharge & \$10 drug fee per entry. \*Includes a \$20 PAC fee (Under Texas Election Code, Chapter 253, the Political Action Committee (PAC) fee is a voluntary contribution. Funding the PAC is important to be able to maintain state funding at the NCHA Triple Crown. Your contribution will provide critical assistance to the NCHA with this effort. To opt out of the PAC fee, submit your payment without the amount indicated as the PAC fee for your class). Checks from a C Corporation can not be accepted by the PAC.
5. Re-instated non-professionals are not eligible to compete in this class.
6. All rules of the 2011 NCHA Super Stakes & Super Stakes Classic will apply in these events where applicable.
7. **Blood and/or urine samples will be taken from Champions and Reserve Champions in all divisions, plus random samples throughout the show.**
