



2006 NCHA Classic/Challenge LIMITED OPEN CONTEST (Contest within Contest)



1. 2006 NCHA Classic/challenge Limited Open Contest will be limited to riders whose lifetime earnings in NCHA-approved and/or sponsored events equal less than \$50,000 as of January 1, 2006.
 - a. The Open class limitation for riders is based on all lifetime earnings and is open to any eligible rider regardless of Open or Non-Professional status.
 2. Nomination fees for Limited Open Contest:

On or before **June 1, 2006** \$500
There will be a 10-day grace period. (Official postmark by US Postal Service)
Late entries will be accepted after the draw, but before the beginning of the first go-round by paying a 50% penalty.
 3. The high scoring twenty percent (20%), with a minimum of six (6) and a maximum of twenty (20), will advance to the finals. Scores from the two go-rounds will be added together in determining the top twenty percent (20%).
 - a. In the event there are less than twenty-five (25) entries in a class,
- as of June 1, 2006, there will not be a working finals. Payout will be made according to the NCHA mandatory payout, **to the highest advancing horse. The score received in the Open finals will determine the placing of the limited, if no entries advance to the finals the score received in the wildcard round will determine placing. If no entries advance beyond the second go round places will be determined by accumulative score.**
- b. All finalists will receive premium checks.
 4. All finalists will be required to pay an additional cattle charge in the amount of \$175 per horse. Deduction will be made from premium check for this charge.
 5. Riders may ride two (2) horses of any sex in the Limited Open Contest.
 6. If a rider has attempted to compete in these classes and is found to be ineligible, disciplinary action may be taken. The burden of proof of eligibility is upon the rider.
 7. All rules of the 2006 NCHA Classic/Challenge will apply in this event where applicable.
