\$200,000 LIMITED NON-PRO CONTEST

(Contest within Contest)



1. The Non-Professional class limitation is based on Non-Professional earnings up to Dec. 1, 1995 plus all money won in all approved classes after that date whose lifetime earnings in NCHA-approved and/or sponsored events equal less than **\$200,000** as of January 1, 2006, and is restricted to current NCHA Non-Professional card holders.
2. Nomination fees for Limited Non-Pro Contest:
On or before **June 1, 2006** \$900
There will be a 10-day grace period. (Official postmark by US Postal Service)
Late entries will be accepted after the draw, but before the beginning of the first go-round by paying a 50% penalty.
3. The high scoring twenty percent (20%), with a minimum of six (6) and a maximum of twenty (20), will advance to the finals. Scores from the two go-rounds will be added together in determining the top twenty percent (20%).
 - a. In the event there are less than twenty-five (25) entries in a class, as of June 1, 2006, there will not be a working finals. Payout will be made according to the NCHA mandatory payout, **to the highest advancing horse. The score received in the Non-Pro finals will determine the placing of the limited, if no entries advance to the finals the score received in the semi-finals will determine placing. If no entries advance beyond the second go round places will be determined by**

- accumulative score.**
- b. All finalists will receive premium checks.
 - c. The highest advancing contestant in the \$200,000 Limit Non-Pro class that is not already in the semis of the Non-Pro event providing semi-finals will receive a bye to those semi-finals. For Non-Pro events without a semi-finals, the highest advancing contestant in the \$200,000 Limit Non-Pro class that is not already in those finals will receive a bye to the finals. If there is a tie, the tie-breaker will be the composite score of all go-rounds and finals in the \$200,000 Limit Non-Pro class.
4. All finalists will be required to pay an additional cattle charge in the amount of \$175 per horse. Deduction will be made from premium check for this charge.
 5. Riders may ride two (2) horses of any sex in the Limited Non-Pro Contest.
 6. If a rider has attempted to compete in these classes and is found to be ineligible, disciplinary action may be taken. The burden of proof of eligibility is upon the rider.
 7. All rules of the 2006 NCHA Derby will apply in this event where applicable.
